

#### 4.6 Program Transition Officer



In the past month we have had a really good response on the Unit Pathways form and workshops.

As of this meeting (22/9/21) we are at ~74% responded. Almost a 35% increase since last meeting.



Region Responses




We are still at about 62% no longer using the old system which is understandable as this is a number that is only expected to grow in early 2022. Similarly, we only had a small increase in badge buying numbers (+3%) although this is likely due to increased data clarity. Again, it is unlikely that this number will grow until lockdown has ended as physical badges don't get awarded unless meetings are in-person.

Pathways Status




Badge Status



Here we get into the juicy part. The data on Terrain usage has changed significantly although the final numbers actually seem to stay the same. Although I have sent out numerous emails explaining how to get setup on terrain, I am currently not receiving feedback on whether the emailed units are indeed taking this on board and getting setup. The only way I can currently find out if units are setup are by using post workshop evaluations. On top of this for every successful workshop that runs, there tends to be two more Unit Pathways form responses that negate the effects of the numbers. 1 step forward, 2 steps back. However, this is no worry as most of the units that respond with 'poor data' (data that brings the statewide transition% down) often are the same ones asking for and receiving workshops.

Terrain Status




Total transition % is still sitting stable at 47%. No surprise here as this is heavily dependent on percentage of people no longer using the old system. To combat this, I have introduced a new stat: 'Transition Ready'

*Transition ready*



This is meant to represent how ready a unit is to use the new system rather than how much of the new system they are using. With this number we can see an appreciable increase over time as workshops are conducted and training sessions are being held.


% Transitioned



Transition Ready




Transitioned and Transition Ready




Regions Transition %




Transition \* Responded



Transition Ready




Transition Ready \* Responses



- VRC Appropriation \$300



- The following recommendation was presented in the report:  
*(6) Appropriate Region Engagement*  
*Though it is proper and appropriate to ensure that Region Chairs are representing their Regions to the best of their ability, it is a basic principle in representative governance that informed decision making does not always include seeking direct input from constituents. There is merit to ensuring maximum engagement from Region Chairs, but there should be a respect for the principles of representative democracy and where extensive prior knowledge or understanding of the minutia of an issue is required, the Region Chairs feel empowered and take on the responsibility of making decisions.*
- The action requested below supports the principle of this recommendation and has been amended after consultation with Region Chairs and Rover Support Commissioners.

#### ACTION REQUESTED

It is recommended that the Victorian Rover Council:

- Require Region Rover Councils to amend position descriptions for the Region Chair role in their respective constitutions and/or policy manuals to reflect the below sentiment.
- While consulting members of the Region prior to making decisions on behalf of them is a core principle of the Region Chair position, it is recognised that this may not always be possible. Informed decision making does not always require seeking direct input from constituents, although is recommended where reasonably practicable.

#### KEY POINTS

- MARB 2021 Game On as an event is fully planned and ready to go and the committee is excited to have the event they've worked hard on actually run.
- Feedback from our ticket holders and other interested Rovers states that they would like to attend this planned event, and don't want to see it cancelled.
- As to not impact the normally running of the events calendar, with respect to the current COVID restrictions roadmap, we propose that the MARB 2021 Game On event be moved to Term 1 of 2022 and that a 2022 committee is formed adjacent to the current committee to plan a new event to run during late Term 3 or early Term 4 2022.
- These two teams would operate completely separately, but crossover between the two teams would be permissible due to current succession planning. The MARB 2021 Game On Chairman will not hold any role on the MARB 2022 team apart from Immediate Past Chair.
- The approximate 6 month gap between events would mean that moving the 2021 event, shouldn't impact on the attendance of the 2022 event. These events would also operate in different financial years.
- MARB 2022 would not put their tickets on sale until the completion of MARB 2021 Game On as to avoid confusion.
- Moving the event would give the potential for higher participant number caps, ensuring the event is at less of a financial risk.
- All current tickets will be transferred to the new date; after a date is locked in, if any current ticket holders cannot attend, full refunds will be provided at their request.

**BACKGROUND**

- No MARB has run since September 2019.
- Cancelling another event would cause a major deficit of skills when it comes to succession planning and lose more “hype” surrounding the event concept.
- MARB 2022 will be the 95th anniversary of the first MARB to run, so it is important to hold such a milestone event, even if it means holding two in the one calendar year.

**ACTION REQUESTED**

It is recommended that the Victorian Rover Council:

- Approve the change of date and the running of two MARBs in one calendar year.
- Support the team as required through this new challenge.
- Action any requested refunds upon request.
- Assist in the Marketing and Communication of this new MARB calendar structure.
